

Call to Order:

Marcina Wagner, President, called the meeting to order at 11:32 a.m.

Approval of Minutes:

A motion was made by Colleen Stamm to approve the minutes from the Spring meeting on April 30, 2010, and it was seconded by Sue Shipe. Motion carried.

Treasurer's Report:

Sue Davis, Treasurer, was absent, so Colleen Stamm read the Treasurer's Report. The previous balance was \$2,202.60. Deposits totaled \$1,427.00. Withdrawals included the bus trip to NYC, a gift for Herb Landau, and refreshments for the Fall Meeting, which totaled \$1,706.58. The ending balance as of November 30, 2010 was \$1,923.02. There are two pending transactions: One is a withdrawal of \$61.00 as a donation to the NYPL, and the other is a deposit of \$146.00. Profits from the NYPL Bus Trip totaled \$156.00.

 - •Corinne App reported that they are currently investigating ways of increasing membership and attendance at functions. Ideas included more collaboration and communication, setting up a Facebook page, and attending college career fairs, such as Kutztown since they offer a Library Science degree.
